- 3000+ bills filed
- @250 bills passed

FAC experienced success in addressing many of its priorities:

- 3 major bills addressing the impact of the opioid epidemic
- A respectable level of beach funding ((\$50 million + \$13 million (Matthew))
- Implementing legislation for renewable energy constitutional amendment that protects existing projects from tax exemptions
- Potential preservation of 10% cap on assessments of non-homestead property
- Protection from burdensome administrative rules with regards to the notice of pollution activity
- A relatively modest impact from the 2017 tax package that included a reduction in the commercial lease sales tax
- \$85 million Florida Job Growth Grant Fund for infrastructure and workforce development



FAC also enjoyed success in having their voices heard as several bills failed to pass:

- Red light camera repeal
- Constitutional Officers / Charter Preemption
- Vacation Rentals
- Local Government Super Preemption
- Local Business Taxes
- Community Redevelopment Agencies

As a result of the 2017 session, Counties will face many policy-related challenges:

- Transportation Network Companies
- Drones & Personal Delivery Vehicles
- Small Cells/ Advanced Wireless Infrastructure Deployment (5G)
- Increased Homestead Exemption
- Implementing Medical Marijuana



Increased Homestead Exemption

- HJR (HB) 7105 (Rep. LaRosa / Sen. Lee)
- Ballot Language <u>Increased Homestead Property Tax Exemption</u>. Proposing an amendment to the State Constitution to increase the homestead exemption by exempting the assessed valuation of homestead property greater than \$100,000 and up to \$125,000 for all levies other than school district levies.
- Effective Date: January 1, 2019

HB 7107 (Rep. LaRosa / Sen. Lee)

- Negates the traditional method of computing the rolled-back rate and the maximum millage to force absorption of impact
- Fiscally constrained county offset appropriation

How did we get here?

Senate (1774); House (7105); & the "Big" trade for "Lake O"



Advanced Wireless Infrastructure Deployment ACT (Small Cells / 5G)

- HB 687 (Rep. LaRosa / Sen. Hutson)
- Limited Preemption to collocate small wireless facilities in the public rights of way
 - Minimum separation distances are prohibited
 - Streamlined permitting
 - Streamlined application
 - 60 days
 - Consolidated application for up to 30 sites
- Local Governments may:
 - Enforce applicable codes (building, fire, etc...)
 - Apply objective design standards by ordinance for small facilities, and new or replacement poles
 - Contextual location, color, stealth and concealment



Advanced Wireless Infrastructure Deployment ACT (Small Cells / 5G)

- Local Governments may (CONTINUED...):
 - Deny collocation if small wireless facilities interfere with:
 - Safe operation of traffic control equipment
 - Sight lines or clear zones for transportation or public safety
 - Compliance with ADA or similar laws
 - Compliance with 2010 FDOT Utility Accommodation Manual
 - Negotiate alternative location of facilities (14 days)(30 days)
 - Apply and enforce height restrictions 10 feet above existing structures; tallest existing poles within 500 feet (ROW); or 50 feet
 - Apply and enforce insurance and performance bonds
 - Require "Make-Ready" work at telcom's expense
 - Rate for collocation attachments is \$150 per year per pole
 - Limit 3rd party infrastructure companies (MOBILITIE) to only do contract work for traditional telecom



Medical Marijuana

- HB 8A (Sen. Bradley)
- Passed during special election 2017A

County Stuff

- No sales tax on marijuana or delivery devices
- Cultivation and processing regulations preempted to State
- Allows governments to ban
- If no ban, regulate similar to pharmicies
- Safe Zones 500 feet from schools unless waived by local governments

Other Stuff

- Maximum of 25 licenses (@ 200k patients) 10 –added by October 2017
- Maximum of 35 dispensaries per license
- Dispensary location determined by zone & proportionate share of population
- Employers will be able to continue "drug-free" workplace policies
- Expanded uses include "nonmalignant chronic pain"
